SUPPLEMENTARY REGULATIONS: PART ONE

1. JURISDICTION:

This event is a Clubmans Rally, promoted by the *Hamilton Car Club Inc* and will take place on *Sunday 6th December 2020* in the Otorohanga /Waitomo area.

The format of this event is a single day, user friendly rally for competitors with an emphasis on fun and low cost. It is an ideal rally for newcomers and clubmans competitors but all are welcome and encouraged to enter.

The Rally will be held under these Supplementary Regulations, the MotorSport NZ National Sporting Code and its Appendices and Schedules particularly Appendix Three, Schedule R being the Standing Regulations for all Rallies and Appendix Two, Schedule A – Driver and Vehicle Safety Requirements.

3. THE EVENT

- **3.1 Venue** The event is a gravel rally starting & finishing Ngutunui School, area. Side of road Servicing after SS2, SS4 & SS5.
- **3.2 Length:** Comprises of *6* special stages totalling 80km and 106km of touring. A full stage description is appended to these regulations.
- **3.3** First Car Starts: From Ngutunui School at 9.30 am
- **3.4** First Car Finishes: At ~3.00pm at the final control which is situated at Ngutunui School

4. ENTRIES

4.1 Entries must be made through the MotorSport Online system (https://online.motorsport.org.nz).

Any entry will not be deemed valid until payment is received.

MotorSport Online will send an invoice for the correct fee (provided you check the correct box) with the Club's bank account details at the bottom. However, for convenience the bank account for entry fees is 06-0317-0335984-01.

Entries received after the normal closing date but received prior to 5 pm on Sunday 29th November 2020 will be subject to the late fee.

Entry Acceptance: Entries shall made on the correct form and to be deemed valid must be complete in all details and <u>accompanied by the appropriate fees</u>. Acceptance will be at the organising committee's discretion. Organisers reserve the right to refuse any entry in accordance with the prescribed provisions of the National Sporting Code.

4.2 Opening and Closing: These open with the publication of these regulations and close at 5pm on 16th November 2020.

4.3 Fees:

(1) Competing vehicle;

2WD Entry Fee \$495.00 including GST 4WD Entry Fee \$595.00 including GST Late Entry Fee \$695.00 including GST

Refunds:

Any Competitor who withdraws from the event later than 5pm Monday 16th November 2020, but prior to 5pm Sunday 29th November 2020, will forfeit 25% of his or her entry fee.

Any Competitor who withdraws from the event later than 5pm Sunday 29th November 2020, but prior to the commencement of documentation, will forfeit 50% of his or her entry fee.

Any competitor who withdraws after the commencement of documentation will forfeit 100% of his or her entry fee.

4.4 Number of Starters:

The organisers reserve the right to abandon the event if less than 35 entries are received at normal closing date. The maximum number of starters will be 50.

Any additional entries received will be placed on the reserve list in order of receipt.

4.5 Acceptance of Entry: (Supplementary Regulations Part Two)

These will be notified by Monday 30th November 2020 together with the seeded start list.

4.6 Competitor Requirements:

- (1) Knowledge and Understandings: In submitting the entry competitors (Entrant and Drivers) are deemed to fully understand the MotorSport NZ National Sporting Code and its relevant Appendices and Schedules. Particularly,
 - (a) The National Sporting Code articles pertaining to protests and competitors obligations, and
 - **(b)** Appendix Three Schedule R articles pertaining to Stage notes, Pace notes and Reconnaissance.
- (2) Licence Requirements: Both the No. 1 and No. 2 drivers shall hold a R1 or R2 Grade or higher MotorSport NZ issued Competition Licence.

If the Entrant is other than a driver, an Entrants licence in the name of the Entrant is required.

(3) New Competitors: Any driver(s) who have not previously competed in three or more rallies must attend the new competitor special briefing. Details of venue and time will be announced in Supplementary Regulations Part 2.

5. ELIGIBLE VEHICLES

- **5.1 Compliance:** All vehicles shall comply with Appendix Two Schedule A and Appendix Three Schedule R of the current MotorSport Manual unless stated otherwise in these supplementary regulations.
- **5.2 Classes:** Vehicles will be divided into the following classes:

A 0-1300cc

B 1301-1600cc

C 1601-2000cc

D 2001 and over

E Open 4WD

F 4WD Pre 1996 up to 2000cc

6. DOCUMENTATION AND SCRUTINEERING AUDIT

Competitors must present themselves at documentation for the checking of licences and documents, issuing of competition numbers and applicable advertising material prior to presenting the car for audit scrutineering and for those cars with forced induction engines, restrictor inspection.

Cars will not be cleared to compete until all of these numbers and advertising requirements are firmly affixed in the appropriate places on the vehicle.

The venue for this will be at Ngutunui School time will be advised in Supplementary Regulations Part 2.

Your actual report time to documentation will be advised in your Supplementary Regulations Part 2.

Competitors may arrange with one of the scrutineers on the list below to perform a scrutineering audit within the two weeks prior to the event. Inspections must be carried out between 21st November - 5th December 2020.

10. RESULTS

Results will be progressively published on www.chrissport.co.nz

11. STAGE NOTES

The use of Stage / Pace Notes is not permitted throughout this Event.

There may be checks for Stage / Pace Notes. Any vehicle or crew found to be carrying Stage / Pace Notes Schedule P A3R.10 will apply.

12. RE-JOINING

The Road book contains a "Temporary Withdrawal" form, a "Final Withdrawal" form and a "Re-joining" form.

No competitor will be permitted to restart the rally if they have handed in a "Final Withdrawal" form.

If a competitor wishes to re-join the event, they can do so at the start control of SS3, SS4, SS5 or SS6. They must re-join at a time that does not cause any delay to the event. They must hand the re-join form to the Post Chief or ACotC at the start control.

All cars that have suffered accident damage must be checked and cleared by a scrutineer **before re-joining**.

13. SERVICING

Servicing is will only be permitted in areas designated in the road book. All competitors must service on a ground sheet and remove all rubbish.

14. RALLYSAFE

"Rallysafe tracking and timing technology will be used by all competitors at this event. An overview of the system which provides significant safety benefits can be found www.rallysafe.com.au

A "one off" cost of approximately \$200 to purchase the wiring kit, brackets and aerials that can be used at multiple even. These must be ordered directly from Rallysafe – https://shop.statusas.com/shop/category/rallysafe/.

B. An event cost for all competitors of \$132.00 is included in the entry fee.

15. RECOVERY

There will be two four-wheel drive winch trucks travelling through each stage behind sweeper car. They will enable you to get clear of the stage as appropriate.

You can negotiate an appropriate fee with them.

16. GENERAL

A. Fuel:

Competitors are reminded to ensure that they are familiar with and abide by the MotorSport NZ Code of Practice – Fuel Handling. This can be found on the MotorSport NZ website – www.motorsport.org.nz

B Change of Co-driver:

Change of Co-driver is permitted at Stage Start Controls. The replacement Co-driver must have completed all Documentation and Scrutineering requirements. Competitors wishing to take this option must advise the Clerk of the Course via an Assistant Clerk of the Course.

Competitors wishing to make this change are advised as per Manual 36 Sch R Article 3. "The crew will not be classified as a finisher" The Co-driver is not permitted to drive the vehicle.

C Food:

Please support the schools that will be providing food throughout the day. Breakfast will be provided at Ngutunui School. More details will be in Supplementary Regulations Part 2

STAGE DESCRIPTIONS

SS1 & 3Te Rauamoa 4.6km

Nice stretch of smooth based flowing road to begin the day. Starts open then tightens to finish.

SS2 & 4 Pirongia West 19.5km

Almost 20k of fantastic gravel. Starts tight and twisty with a good workout for the first half. Then opens up down the valley for the second half with fast flowing surface. Great road with a bit of everything.

SS5 Kaimango 15.8km

Part of the classic Waitomo final stage. Nice flowing road fairly open to begin with. After the junction tightens for the last 9km but again a great smooth surface.

SS6 Kaimango/Honikiwi 16km

First half of SS5 then turns into Honikiwi for a road not used before. Honikiwi section will be a great challenge to finish. 7kms of tight twisty but very smooth gravel. Stay alert for this one, a few long corners to reward the brave or catch those celebrating too soon
