SUPPLEMENTARY REGULATIONS

1. JURISDICTION

This event is a Hillclimb promoted by the **Hamilton Car Club** and will take place on **Sunday 21ST of March 2021** in the Karapiro area. This is a Clubsport Advanced status event.

The event will consist of 4 runs along Stokes/Head Roads, starting at approximately 7 Stokes Road and finishing at Head Road, which will be run in an anti-clockwise direction (traditional long course). We will be starting with a practice run, then 3 timed runs. Fastest time from any one of 3 timed runs will determine the winner for the day. There may be time for another run if the day allows, this will not be timed and will not be counted for fastest time of the day.

Uncaged cars may run at the absolute discretion of the Clerk of the Course.

To be held under These Supplementary Regulations, the MotorSport NZ National Sporting Code and its Appendices and Schedules particularly Appendix 5, Schedule C being the Standing Regulations for all Clubsport Events and Appendix 2, Schedule A – Driver Safety and Vehicle Requirements.

Venue: Stokes/Head Road, Karapiro area.
Length: 3.5 km approx.
Starts: At Stokes Rd on Sunday 21st March at (earliest) 9:00am.
Finishes: At Head Rd on Sunday 21st March at (latest) 5:00pm.

4. ENTRIES

These open with the publication of these regulations.
Normal entries will close at 3.00pm, Saturday 20th March 2021.
Entries to be made through possum.motorsport.org.nz only.

Acceptance will be at the organising committee's discretion.
Organisers reserve the right to refuse any entry in accordance with the prescribed provisions of the National Sporting Code.

Any additional entries received after the closing date will be included at the organisers discretion.
No entries will be accepted on the day unless previously approved with Clerk of the Course.

- B. *Number of Starters:*
The organisers reserve the right to abandon the event if less than 30 entries are received at normal closing date. The maximum number of starters will be 55.
- C. *Acceptance of Entry:*
Acceptance of entry will be at the absolute discretion of the organizers.
Preference will be given to Hamilton Car Club members where possible.

Please check the website for event updates and information from time to time.

- D. *Competitor Requirements:*

In signing the entry forms competitors (Entrant and Drivers) are deemed to fully understand the MotorSport NZ Inc. National Sporting Code and its relevant Appendices and Schedules, in particular, the National Sporting Code articles pertaining to protests and competitor's obligations.

- A current Car Club Membership
- A Protective Helmet conforming to Motorsport New Zealand Inc. specifications
- Clean protective overalls and footwear conforming to Motorsport New Zealand Inc specifications. (Refer Schedule A)

E. Licence Requirements:
Driver must hold an M Grade Licence or higher.
All driver(s) must attend the briefing at **8.30am** on Sunday 21st March at the venue.

F: Passengers allowed in cars with suitable roll cages, safety harness and wearing appropriate safety gear (overalls and helmet) at the **DISCRETION OF THE CLERK OF COURSE**.

Competing drivers may participate as a passenger, but only with junior drivers who are gaining experience at club level. This shall be disclosed at the documentation to the Clerk of the Course.

Any objections are to be raised prior to the event with the Clerk of the Course.

All passengers must sign an indemnity form on the start line of each run. Passengers must be over 12 years of age and if less than 16 years of age must have signed consent of parent or have a restricted Competition License.

5. **ELIGIBLE VEHICLES**

Uncaged cars will be at the discretion of the Clerk of course.

All vehicles must conform to the vehicle safety regulations contained in, Schedule A, Non-registered vehicles will be allowed to compete but must be trailered back, or wait at the end of the road until the run has finished and then tour back along the closed road ahead of the course clearance vehicle.

Turbochargers are not restricted.

Vehicle conforms to Schedule A specifications.

All tires must be dot approved types, in a road legal condition.

7. **DOCUMENTATION AND SCRUTINEERING AUDIT**

Competitors must present themselves at documentation for the checking of licences and documents, issuing of competition numbers prior to presenting the car for audit scrutineering.

Cars will not be cleared to compete until all of these numbers are firmly affixed in the appropriate places on the vehicle.

9. **OFFICIAL BULLETINS**

May be issued in accordance with the provisions of the National Sporting Code.

10. **OFFICIAL NOTICE BOARDS**

These will be located at the following venue:

11. **RESULTS**

Provisional results will be posted at The Hamilton Car Club Bus. Organisers will post times after each run. Confirmation will be by Facebook on the Hamilton Car Club page once finalised.

12. **SPECTATOR PROVISIONS**

There are no spectator points at this event due to the layout. Please be aware if entering on Private Property as there are guard dogs on two sections. Enter at your own risk – you have been warned!

13. **EVENT DIRECTIONS**

Competitor access to the venue is from Hamilton head south through Cambridge on SH 1. Once through Cambridge turn right after the bridge (at the bottom of the hill) signposted for Te Awamutu. Follow this road for 1.9km (Straight through at the roundabout) then turn left onto Browning Street, signposted for Lake Karapiro. Follow this road for 15km past Karapiro Lake Domain before turning left onto Head Road. Parking will be in the paddock for all vehicles and trailers, please do not park on the side of the road, in the interests of safety and as part of our safety plan requirements.

14. **GENERAL**

- a) **No dogs or alcohol at the venue.**
- b) **Please collect all rubbish in the interest of good MotorSport public relations**
- c) **All competitors to supply and service on a ground sheet within the service area.**
- d) **Servicing is only permitted in the designated service area.**
- e) **All competitors will be required to pay for any fencing or property damage costs incurred within seven days of the fencing account being presented.**

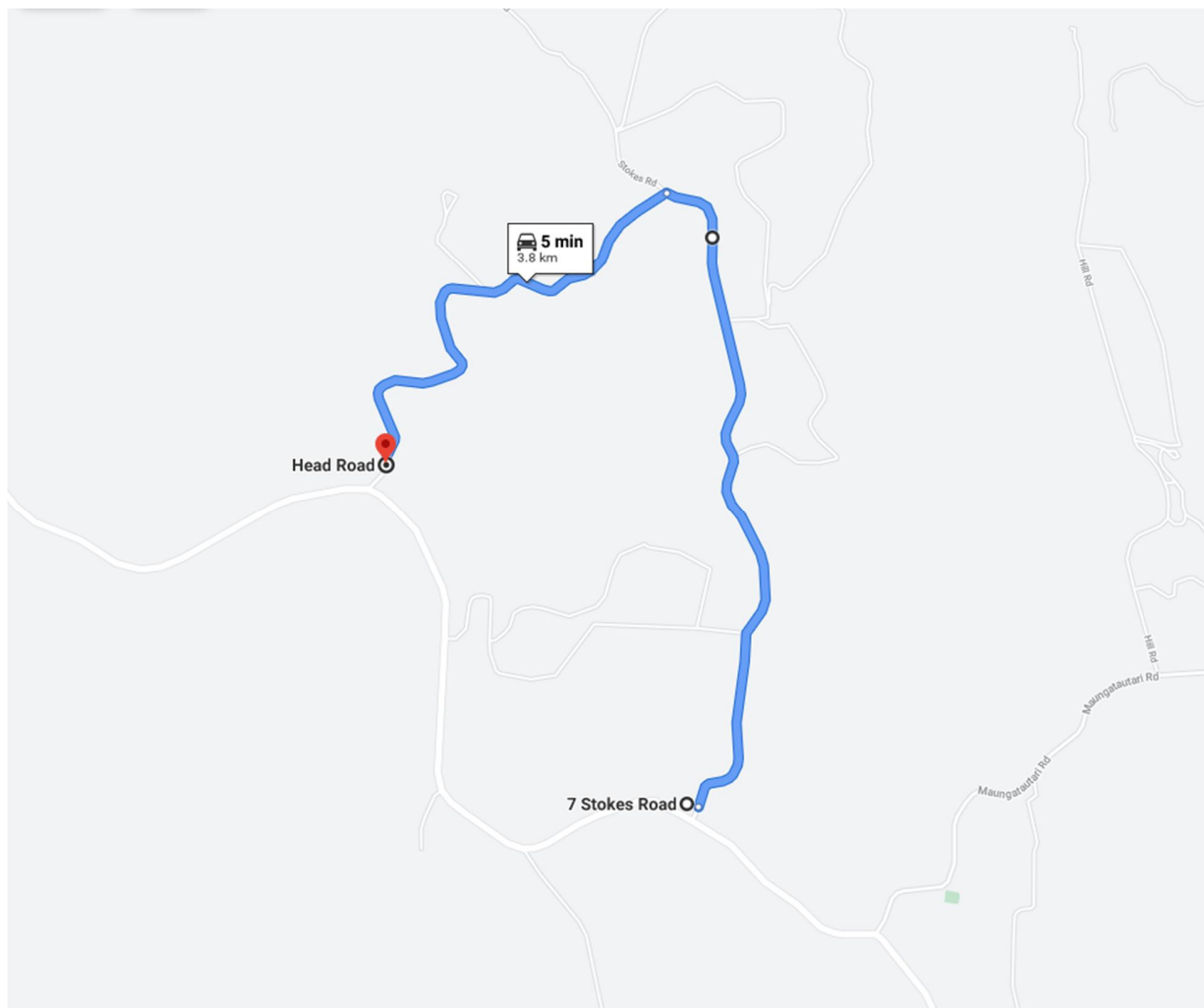
- f) On release of these regulations any competitor seen travelling the course before the start of the event will be excluded from the event and fined in accordance with NZ Motorsport Manual.
- g) **DUAL DRIVERS:** Dual driver vehicles will be allowed, but there will only be one group of cars allowed to tour back through the stage at the completion of each run. For dual driver vehicles it will be the competitor's responsibility to get the vehicle from the end of the course back to the start for the second driver to compete.

If vehicles are unregistered or have no w.o.f then they must be trailered back to the start in time for the second driver to compete. Dual driver competitors must make themselves known to event organisers at documentation to receive suitable starting numbers.

- h) **STARTING ORDER:** Starting order will be in numerical order for each run, or where dual drivers are concerned, as they see fit. Line up as soon as possible after drivers briefing.

15. MAPS

Course Route - Starting at approximately 7 Stokes Road, running from South to North, to the Finish line located just before 18 Head Road.



16. AFTER FUNCTION

To be held at the Five Stags Leamington following event, located at 9 Campbell St, Leamington, Cambridge. All Welcome to attend, no doubt there will be a few stories from the day to be told! Please drink responsibly. This will be at your own cost.
